- The highest bidder shall be the Purchaser and if any dispute shall arise between two or more bidders, the Lot in question may be put up again and resold at the Auctioneers sole discretion.
- Each Lot after being knocked down shall be considered as delivered to the Purchaser thereof, and the Auctioneers will not neither will any person in their employ, hold themselves responsible for the safety of such Lot.
- Payment in full shall be made by the Purchaser to the Auctioneers on the day of sale and if demanded by the Auctioneers or their clerk at any time during the progress of the sale shall be paid forthwith.
